Ikastola: Basque School



Association of families of 15 schools.

Aims: institutional representation of schools; pedagogical coordination, training programs for teachers, administrative and pedagogical advice for schools.

Family subsidized cooperatives, mixed and laic, that use the Basque language as a vehicle for the education, which has the objective to promote Basque culture with an interest in the pedagogical innovation.



Navarre in figures

1. Nafarroa / Navarra:

- * Historically: historical independent Kingdom.
- * Citizens: 600.000 / Capital: Pamplona-Iruña / Official languages: Spanish & Basque
- * Unemployment rate: 15% (Spain 23% and Germany 5%).
- * Sectors: industry and services (car, wind power, healthcare, education).

2. Administration - Education:

- * Central administration (Spain).
- Regional administration (Navarra has some attributions in education).

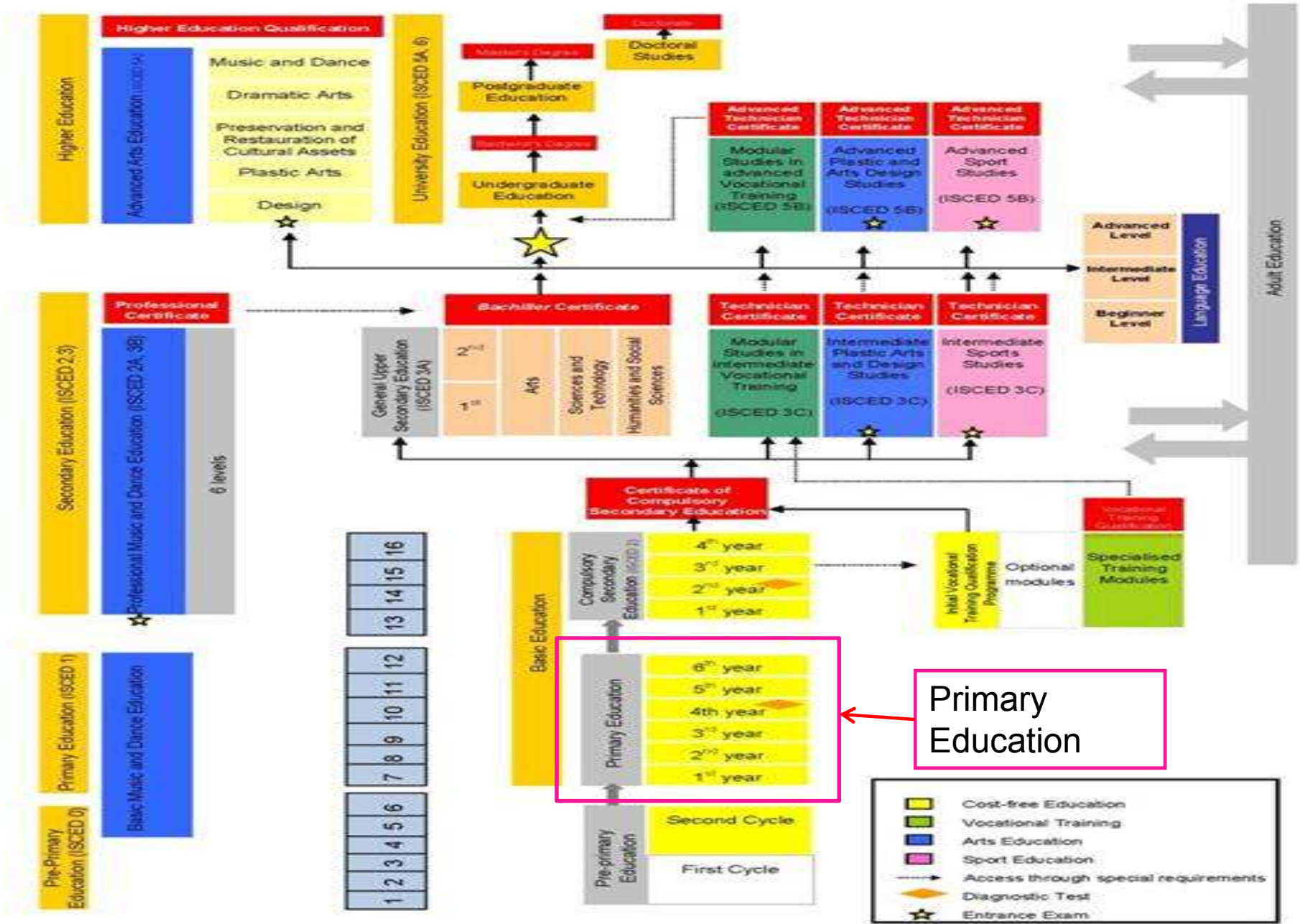

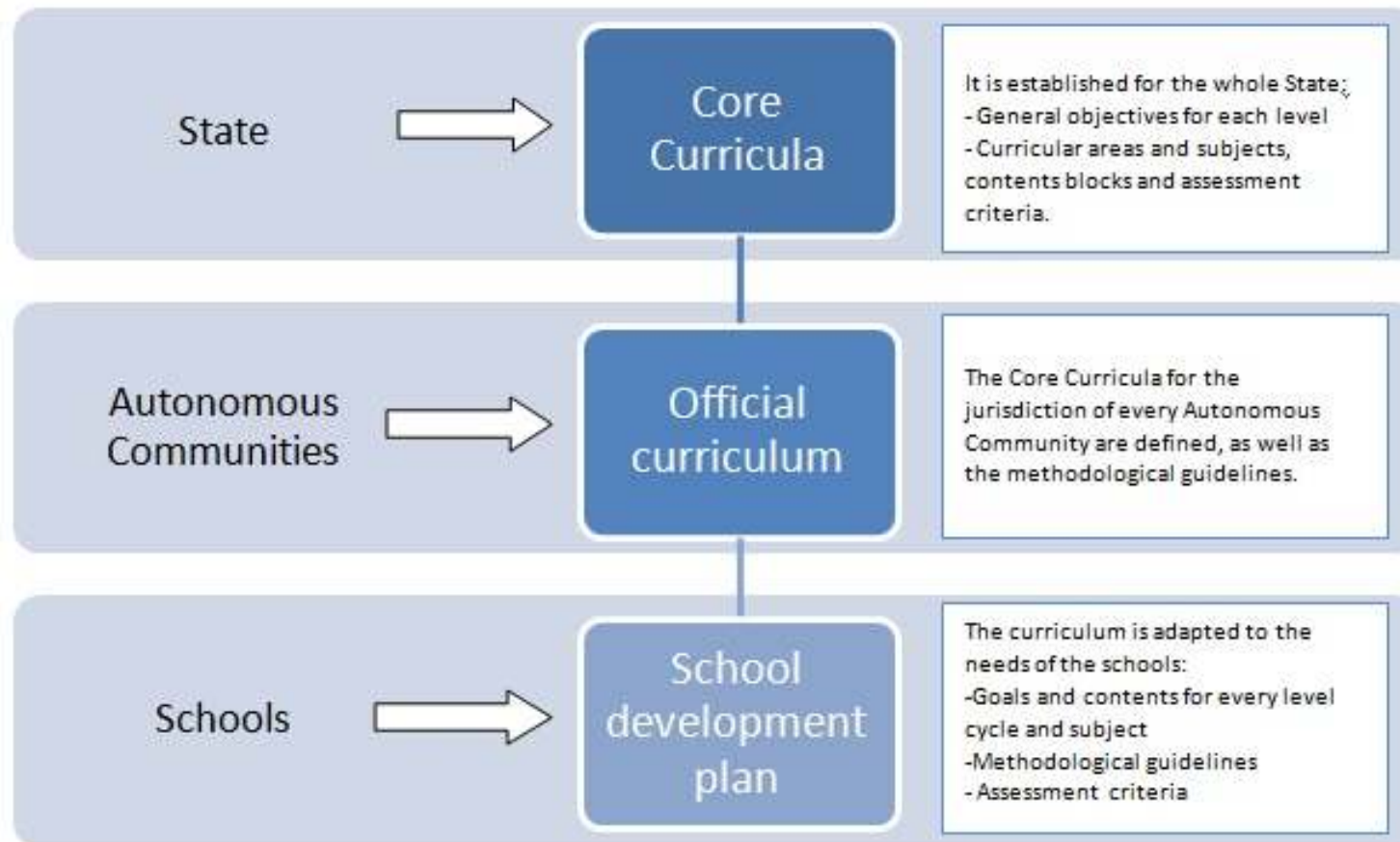


Primary Education

- **Pre-primary education** is up to 6 years of age. Although it is not a compulsory education stage, the second cycle is free in all publicly-funded schools (public schools and [publicly-funded private schools](#)).
- **Basic education** is compulsory and free in publicly-funded schools. It lasts ten years and it is divided into two stages:
 - **Primary education (6-12 years old)**
 - **Compulsory secondary education (12-16 years old)**
- **Upper secondary education** is also provided in secondary schools. It lasts two academic years, usually studied between the ages of 16 and 18. **Bachillerato** (general branch) and **intermediate vocational training** (professional branch).

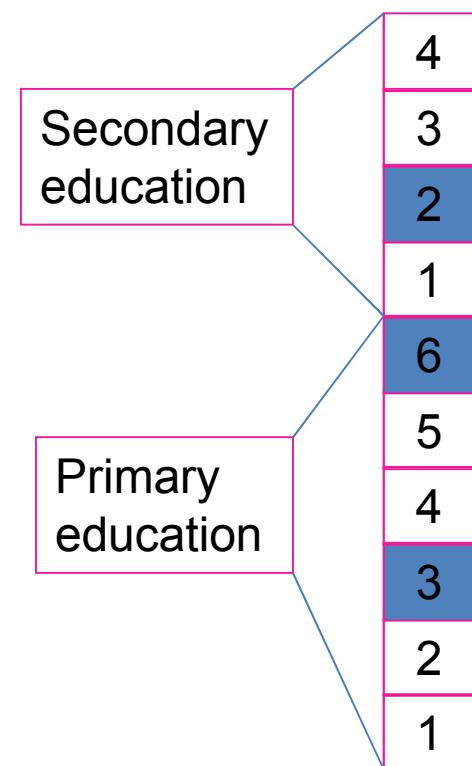
1. **Communication in Language**
2. **Competences in mathematics, science and technology**
3. **Digital competence**
4. **Learning to learn**
5. **Interpersonal, intercultural and social competences and civic competence**
6. **Entrepreneurship and cultural expression**
7. **Cultural awareness and expression**

Teacher training in competences at a State or regional level

- **COMBAS: A program (led by the Ministry of Education) that focus on the planning of the curriculum, is a competence based approach. An ambitious program with an approximately 3% of school participation in Navarre.**
- **Atlantida: a regional project (Canarias island)**

Assessment of Competences?

- It is established that "*diagnostic assessments*" shall be conducted on the basis of the key competences defined by the Act, adding that they "*shall be used for formative and guidance purposes*".
- **Primary Education:** has a 6 year duration and the diagnostic assessment it will be conducted in the 3th and 6th year. Until now it has being mainly an academic evaluation but not an evaluation of competences.
- **Secondary Education** has a 4 year duration and the diagnostic assessment is made in the 2nd year.

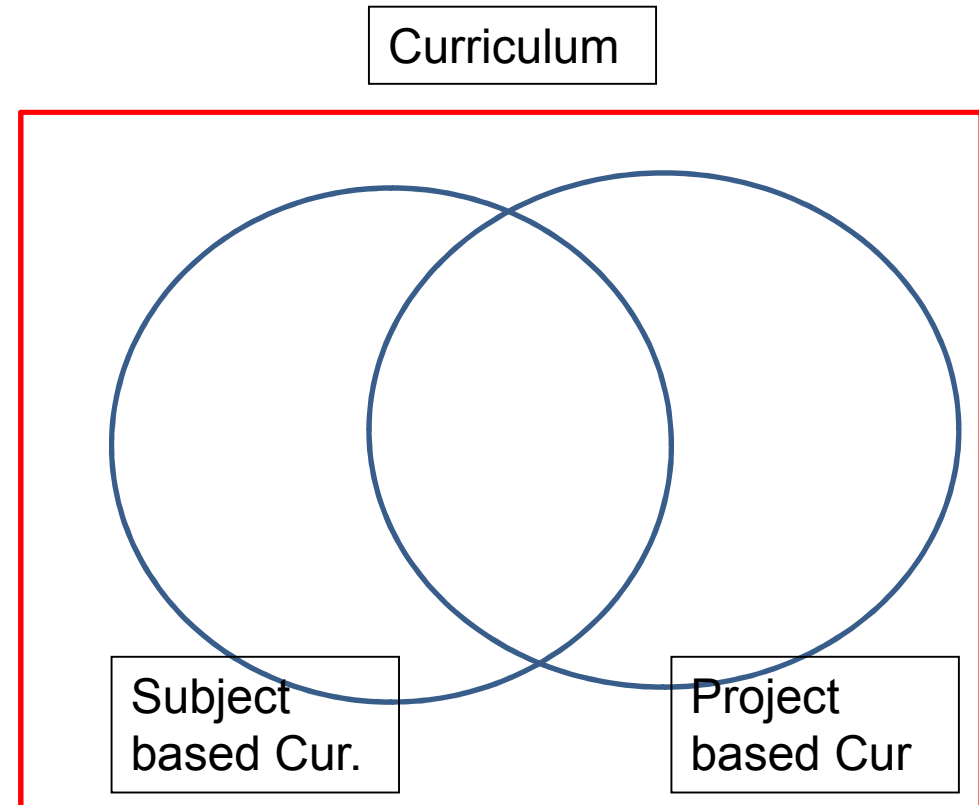

- C) For us the curriculum is the fusion and interrelation of A and B.



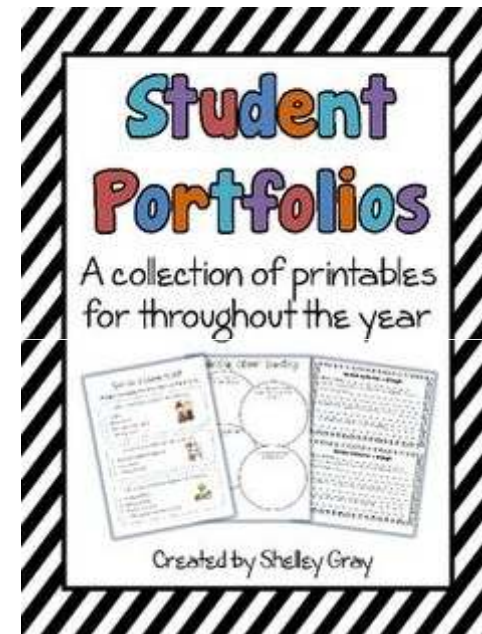
Teacher training

- It is an integrated part of the BLOK project.
- Projects are made and are implemented by teachers with the consulting of experts of our organization.
- We reach the developing of professional competences of teachers: Action research in teacher training.



Evaluation of the competences of Students

- We use the student portfolio as the instrument for the evaluation.
- We have criteria based evaluation of each competence.
- We have developed an application (spreadsheet) for the qualification of the competences of each student.

- During the last 7 years NIE:
 - 7 schools have been working in BLOK
 - 84 projects have been made and applied
 - Approximately 2885 students have been implicated
 - More than 150 teachers have been trained
